As a member of the UFA, the Security Benefit Fund (or welfare fund) will provide optical, prescription and dental benefits. These benefits will be explained to you on August 26<sup>th</sup>, this information is also available online at www.ufanycbenefits.org or www.ufanyc.org (you will be asked to register on the second ufanyc.org website). FDNY HQ will be providing your medical benefits, not the UFANYC union.

# **DOCUMENTATION NEEDED for coverage (Pharmaceutical, Dental, Optical):**

On August 26<sup>th</sup>, please bring the documentation that pertains to your situation. If you are submitting documents after August 26th, please email documents to sbfstaff@ufanyc.org or fax them to 212-683-0693.

## - FRONT section

#### If you are MARRIED:

Provide a copy of your Marriage Certificate – please write down on the copy, your spouse's name AS IT APPEARS on their Social Security Card, as well as their FULL Social Security Number. If you have a Domestic Partner, we will need a copy of your certificate and your Domestic Partner's full Social Security Number.

#### If you have DEPENDENT CHILDREN:

A copy of your child's birth certificate – and the child's FULL Social Security Number.

## **BENEFICIARY ENROLLMENT CARD (Death Benefit and Compensation Accrual Fund):**

Beneficiary is any person or persons you choose to leave your **Death Benefit** (\$10,000) or **Compensation Accrual Fund** to (takes effect after 5 years of service).

You can digitally fill out the enrollment card below ahead of time (see attached), but you must sign and date it by hand on August 26<sup>th</sup> and submit it in person. This is a legal document, please provide all the information requested. After August 26<sup>th</sup>, if you need to make any updates, they can be made online using DOCUSIGN from the UFA website use **QR code** or go to **www.ufanycbenefits.org**.

Please note that this is ALL contingent upon your being sworn in as a probationary firefighter on August 26th. This email is not in an official capacity of any kind. The UFA labor union and the SBF Welfare Fund are trying to have probationary firefighters in the database and ready to go for August 26th. If you choose not to become a member of the FDNY, please email us. Once you are OFFICIALLY a member of the FDNY and UFA, if you have any questions, please contact the Security Benefit Fund staff at sbfstaff@ufanyc.org or call 212-683-4723 and press 2 for a benefits associate.
