### 2021 APPLICATION GUIDELINES

**APPLICATION DEADLINE IS FRIDAY OCTOBER 1, 2021**  
APPLICATIONS POSTMARKED AFTER THE DEADLINE  
WILL BE AUTOMATICALLY INELIGIBLE AND DISCARDED

Please note there are **separate applications** for **active/deceased** members and their dependents and for dependents of **retired** members.

**PLEASE USE APPROPRIATE APPLICATION.**

- Applicants must be currently enrolled in an accredited college, trade or vocational school **full-time** as of the **2021 Fall Semester**.
- High School and Graduate students are **not** eligible for awards.
- Students may receive a maximum of **FOUR (4)** UFA Scholarship Fund Awards.
- Dependents are only eligible up until the age of 23.
- The annual number and amount of scholarships are dependent upon the amount of available funds. If applications exceed the number available, awards will be selected by lottery.
- **Proof of Enrollment** as of the **2021 Fall Semester** for **full-time students** (12 credits minimum) in the form of an official letter from the school confirming enrollment **AND** credit load (not an acceptance letter) **OR** official schedule showing number of credits **must be submitted with application**. Applicants missing this will be disqualified from consideration.
- To avoid unnecessary delay and to ensure receipt of your application, please mail application and proof of enrollment by **US Postal Service Return Receipt**. Scholarship staff **CANNOT** check to see if your application was received without this!
- **Faxed applications will not be accepted.**
- UFA Scholarship Fund awards will be available once per year, not per semester.
- **Award checks will be mailed to the address you provide on the application, not necessarily the member's address.**
- **Dependent** children of active, retired, or deceased Firefighters, Fire Marshals, or Marine Wipers who are full-time students up to age 23, and active UFA members and their spouses are eligible to apply for scholarship awards for **undergraduate** education.
- **Dependent** children and spouses of LOD deceased UFA members, and dependent children of non-LOD deceased UFA members will receive scholarship awards for **undergraduate** education but **MUST** still fill out an application and provide required proof of enrollment (as above).
