UFA FIRE MARSHAL REPRESENTATIVE VACANCY

Members are advised that effective February 11, 2023, UFA Fire Marshal Representative Kevin Lunny will be promoted to Lieutenant, vacating his position on the UFA Executive Board.

In accordance with the UFA Constitution, (Article VI, Section 6) UFA President Andrew Ansbro will appoint an Interim Fire Marshal Representative until a successor is named in a Special Election, to be held within 60 days of the position's vacancy. Additionally, this section of the Constitution states that appointments made by the President must be of a member that is a current delegate, or a current or former member of the Executive Board.

Fire Marshal Delegates interested in being appointed to Interim Fire Marshal Representative should contact UFA Recording Secretary Vincent Speciale at (347) 899-6050 or RecordingSecretary@ufanyc.org as soon as possible. Members of the Bureau of Fire Investigation in good standing are eligible to vote for or serve as Fire Marshal Representative. The UFA expects that the interim appointment of Fire Marshal Rep will take place at the February General Membership Meeting, scheduled for February 9, 2023.

The appointed Interim Fire Marshal Rep will assume the position until the winner of the Special Election is announced. The UFA anticipates that the ballot count will take place on or about April 11, 2023. Election dates will be announced and confirmed on a future 65-2.

Fire Marshals wishing to run for the position of Fire Marshal Representative in the upcoming Special Election must submit nominating petitions, signed by at least 25 active Fire Marshals in good no later than 5 PM on Wednesday, March 1, 2023. Petitions must be returned to the Office of the Recording Secretary via hand delivery, mail, email to RecordingSecretary@ufanyc.org or faxed to 212-683-4359. The petitions will be validated by the Election Committee prior to the Nomination Meeting, which is expected to take place on Thursday, March 9, 2023, at the March General Membership Meeting. Details will be announced on an upcoming Meeting Notice.
